At the same time, students increase learning, teachers are supported, student achievement increases, and school climates become more parent friendly.

#### 3. Program Description

This section contains the full program description of the funding opportunity.

- i. Required Information
  - 1. The general purpose of the funding is to fund a Parent Mentor Program for families on TANF and it is expected to assist primarily low-income, African American and Latino parents with the goal of becoming leaders in their communities, for their families and for themselves for the public good.

- 2. This grant is intended to fund Community Based Organizations (CBOs) that will provide employment and training programming consistent with the TANF E&T program manual and policies.
- B. The State agency's funding priorities or focus areas.
  - 1. IDHS is working to counteract systemic racism and inequity, and to prioritize and maximize diversity throughout its service provision process. This work involves addressing existing institutionalized inequities, aiming to create transformation, and operationalizing equity and racial justice. It also focuses on the creation of a culture of inclusivity for all regardless of race, gender, religion, sexual orientation, or ability.
  - 2. IDHS intends to fund Community Based Organizations (CBOs) that will provide employment and training related programming in an effort to increase economic sustainability consistent with the TANF state plan. IDHS will prioritize applications from eligible applicants who provide services in geographic regions where other TANF E&T services are not offered and who are able to contribute to skills gains, employment or greater economic stability for TANF recipients.
  - 3. IDHS intends to prioritize applications from eligible applicants who provide services in geographic regions where other services are not offered and/or are in high need areas, having a disproportionate amount of economic hardship or food insecurity.
  - 4. IDHS is also focused on removing barriers that exist for Returning citizens/reentry programs that connect formerly incarcerated individuals with career pathways.
  - 5. IDHS will also prioritize funding programs that provide language access and cultural competence to meet the needs of all populations (ie. immigrant and refugee).
- C. Goals and objectives of the Program
  - 1. The goal of this program is to give parents opportunities to learn more skills, further their education and/or employment opportunities and become positive role models for their children while also increasing student learning and support for teachers.
  - 2. This grant is intended to fund Community Based Organizations (CBOs) that will provide employment and training programming consistent with the TANF E&T program manual and policies.
- D. Program Deliverables
  - For the contract period (July 1 through June 30), stipends of \$1,500 are be paid to parents who provide 100 hours of tutoring and mentoring services through the Parent Teacher Mentor (PTM) Program. As funding permits, parents will receive a second stipend of \$1,500 after providing an additional 100 hours of tutoring and mentoring services.
  - Eligible parents must be active TANF customers or TANF-eligible individuals with minor dependent child(ren). TANF-eligible individual's income must be verified as being at or below 200% of the Federal Poverty Level prior to being eligible for services.
  - 3. A maximum of 3 stipends, up to a maximum of \$4,500.00 may be issued.
  - 4. Stipends for parents who receive TANF do not need to be reported as income.
  - 5. Grantee is solely responsible for recruitment for the program.

- 6. The grantee is required to verify TANF eligibility via IES or through communication with the FCRC. Documentation should be kept regarding all parent mentors including records of their hours which will be reviewed by the Department.
- E. Performance Measures and Standards
  - 1. 100 % of stipends are issued to eligible parents and that no participating parent receives more than 3 stipends in a contract year
  - 2. 100 % of the required reports are submitted timely,
  - 3. 100% of participating schools have mentors assigned to them
