Program Description

The Downstate Cooperative Transportation Grant Program was created by Public Act 104-466 within Article V of the Downstate Public Transportation Act (30 ILCS 740). Subject to appropriation, IDOT may award competitive grants to eligible public transit agencies to establish cooperative transportation programs in partnership with public school districts, regional offices of education, public career centers, and public technical education centers administered by the Illinois State Board of Education.

The program supports partnerships between public transit agencies and educational institutions to provide transportation access for students. Eligible activities may include transportation services, specialized transportation for students with disabilities during off-peak service hours, vocational and career education transportation, planning, scheduling and coordination activities, transportation equipment, infrastructure, and other capital needs necessary to implement the approved program. Cooperative programs may not operate exclusive school bus service in direct competition with private school bus operators

Funding Source Description

Funding will support eligible costs associated with establishing and implementing approved cooperative transportation programs between public transit agencies and educational partners. Eligible costs may include operating expenses, planning and coordination activities, vehicle and operator costs, transportation equipment, infrastructure, and other capital needs necessary to carry out the approved program. Applicants must submit a detailed budget identifying administrative, operational, and capital costs. Reimbursement will be based on actual, documented eligible costs and may not exceed the upper limit of the grant agreement.

Funding Restrictions

Costs must be directly related to the approved cooperative transportation program and scope.

Costs reimbursed through this program may not also be reimbursed through another State or federal funding source.

Cooperative program funding may not be used to cover a funding shortfall for an Illinois Safe Routes to School project.

Cooperative programs may not operate exclusive school bus service in direct competition with private school bus operators.

Reimbursement is limited to actual, documented eligible costs and the upper limit of the grant agreement.

Applicants must submit sufficient documentation to demonstrate that the proposed cooperative transportation program is ready to implement and supported by appropriate educational partners. At a minimum, the application must include:

OP-3 – Description of Applicant's Organization

Scope – A detailed scope that explains transportation delivery, availability of service, vehicle and operators, and programmatic readiness. The scope should also clearly identify the role and responsibilities of each proposed educational partner and describe how the partnership will support transportation delivery. In addition, the scope should clearly describe how students will be enrolled and how student ridership will be tracked.

Demonstrated Transportation Need and Feasibility – Documentation that clearly identifies a lack of transportation for school-aged children. Communities that have received Illinois Safe Routes to School (SRTS) funding within the last two years will be required to demonstrate a coordinated plan that incorporates both programs to maximize student access to school. If there is a shortfall in completing the Safe Routes to School project, the applicant must describe how the shortfall will be covered. The Cooperative program funding cannot be used to supplement the Safe Routes project.

List of Proposed Educational Partners – A list of the public-school districts, regional offices of education, public career centers, and public technical education centers expected to participate in or support the proposed program.

Areas of Mobility and Economic Hardship Index– Mobility and economic hardship will be evaluated using indicators such as household income, housing cost burden, employment conditions, travel time, vehicle availability, traffic intensity, and access to reliable transportation. These factors will help identify communities where economic conditions and transportation barriers demonstrate a greater need for program assistance.

Letters of Support – Letters demonstrating support for the proposed program from educational partners or other appropriate community partners.

Evaluation & Scoring

Criteria

Detailed Scope – 30 points: Completeness and feasibility of the proposed program, including transportation delivery, service availability, vehicle and operator availability, program readiness, educational partner responsibilities, student enrollment and ridership tracking, and the proposed fare structure.

Demonstrated Transportation Need and Feasibility – 35 points: The extent to which the application identifies a transportation need affecting school-aged children and demonstrates that the proposed program can reasonably address that need.

Educational Partner Participation and Community Support – 25 points: The level of participation and support from educational partners and other appropriate community partners.

Areas of Mobility and Economic Hardship Index – 10 points: Mobility and economic hardship based on factors such as household income, housing cost burden, employment conditions, travel time, vehicle availability, traffic intensity, and access to reliable transportation.

Review & Selection Process

Complete applications will be competitively reviewed and scored by IDOT. Applications will be ranked based on their total score. Funding selections will consider application scores, available funding, and overall program demand. IDOT may fund an application in full or at a reduced amount and may establish an award limitation based on the number of qualified applications received.

As a condition of the grant agreement, an Opinion of Counsel must be signed by the public transit agency and each participating school district at the time the grant agreement is executed.

Reporting

Participating agencies will submit quarterly reimbursement requests based on actual eligible costs incurred under the grant agreement. Reimbursement will be based on actual documented eligible costs associated with the approved scope and will not exceed the upper limit of the grant agreement.

Participating agencies will submit quarterly reimbursement requests on an IDOT-provided form.

At a minimum, the form will require the following information:

Number of student trips provided Service provided during the reporting period Eligible expenditures incurred by cost category Progress toward the approved scope and program objectives Amount requested for reimbursement Transit agencies must maintain source documentation sufficient to support all quarterly reimbursement requests and demonstrate that expenditures were incurred for the approved program. IDOT may require additional documentation or supporting information as necessary to validate reimbursement requests and ensure compliance with the grant agreement.

Health Insurance Portability and Accountability Act: Applicant certifies that it is in compliance with the Health Insurance Portability and Accountability Act of 1996 (HIPAA), Public Law No. 104-191, 45 CFR Parts 160, 162 and 164, and the Social Security Act, 42 USC 1320d-2 through 1320d-7, in that it may not use or disclose protected health information other than as permitted or required by law and agrees to use appropriate safeguards to prevent use or disclosure of the protected health information. Applicant shall maintain, for a minimum of six (6) years, all protected health information.

17. Criminal Convictions: Applicant certifies that neither it nor any officer, director, partner or other managerial agent of Applicant has been convicted of a felony under the Sarbanes-Oxley Act of 2002, nor a Class 3 or Class 2 felony under Illinois Securities Law of 1953, or that at least five (5) years have passed since the date of the conviction. Applicant further certifies that it is not barred from receiving an Award under 30 ILCS 500/50-10.5, and acknowledges that Grantor shall declare the Award and subsequent Grant Agreement void if this certification is false (30 ILCS 500/50-10.5).

18. Federal Funding Accountability and Transparency Act of 2006: Applicant certifies that it is in compliance with the terms and requirements of 31 USC 6101. Applicant further certifies it does and will comply with the reporting requirements of the Federal Funding Accountability and Transparency Act of 2006 (P.L. 109-282) (FFATA) with respect to Federal Awards greater than or equal to \$30,000. Never Contract with the Enemy: Applicant certifies that it will comply with guidance implementing Never Contract with the Enemy in 2 CFR part 138 for covered contracts, grants, and cooperative agreements that are expected to exceed \$50,000 during the period of performance, are performed outside the United States and its territories, and are in support of a contingency operation in which members of the Armed Forces are actively engaged in hostilities. 22. 2. General Assurances:

Applicant assures it will comply with all applicable State, Federal, and local laws and State administrative regulations in carrying out any project supported by a State of Illinois Grant Agreement or Intergovernmental Agreement, and any and all license requirements or professional certification provisions.
- ii. Applicant agrees that it is under a continuing obligation to comply with the terms and conditions of the Grant Agreement or Intergovernmental Agreement with Grantor issued for its project.
- iii. Where applicable, Applicant assures it will comply with applicable State and Federal statutes, Federal regulations and Grantor administrative rules regarding confidential records or other information obtained by Applicant concerning persons served under an Intergovernmental Agreement or Grant Agreement. The records and information shall be protected by Applicant from unauthorized disclosure.
- iv. Applicant recognizes that Federal and State laws and regulations may be modified from time to time, and those modifications may affect project implementation. The Applicant understands that Presidential executive orders, executive orders from the Office of the Governor, Federal and State directives, including policies and program guidance may be issued concerning matters affecting the Applicant or the project.
